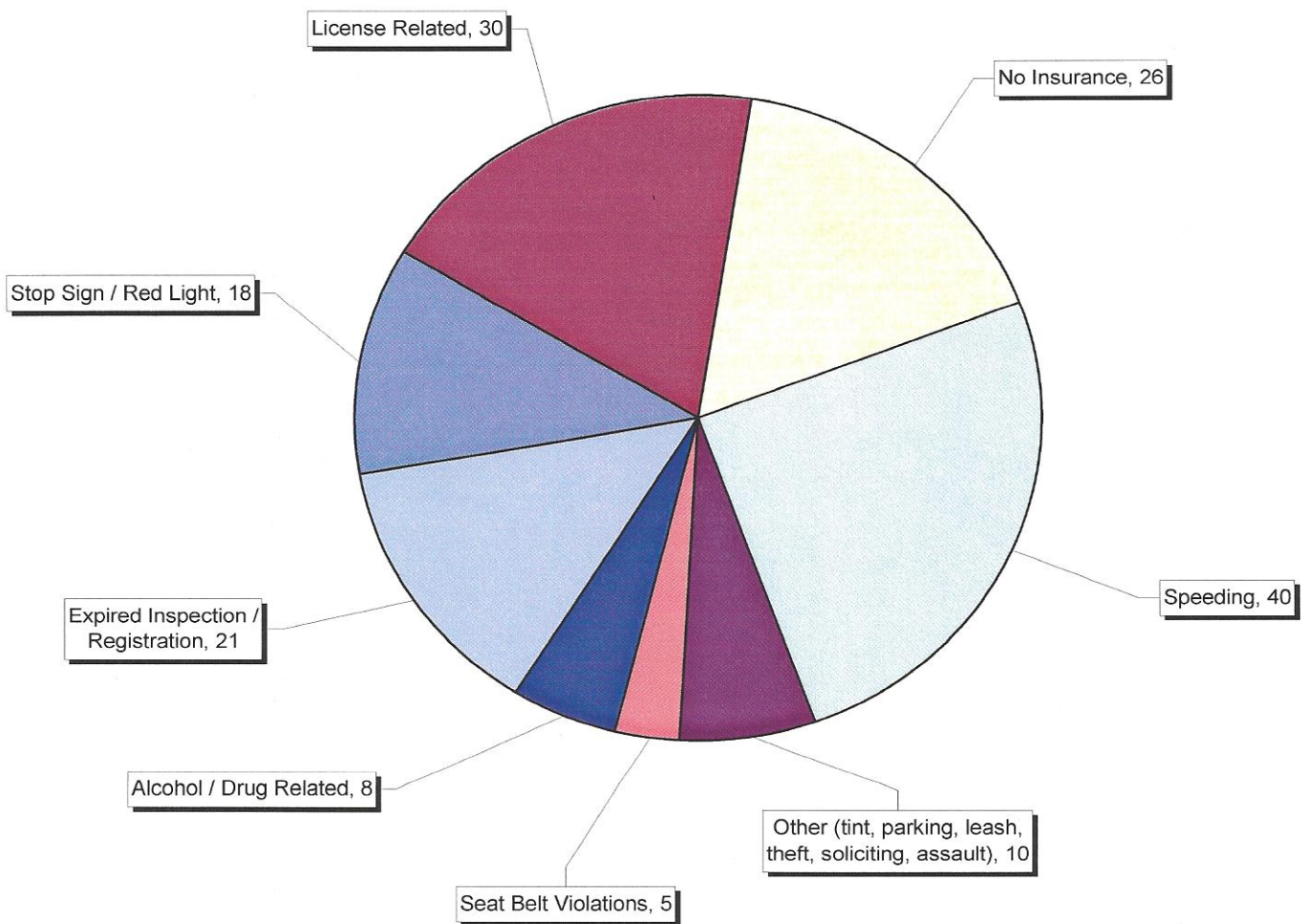

Traffic Enforcement Data

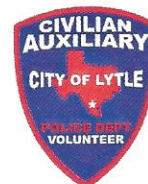
