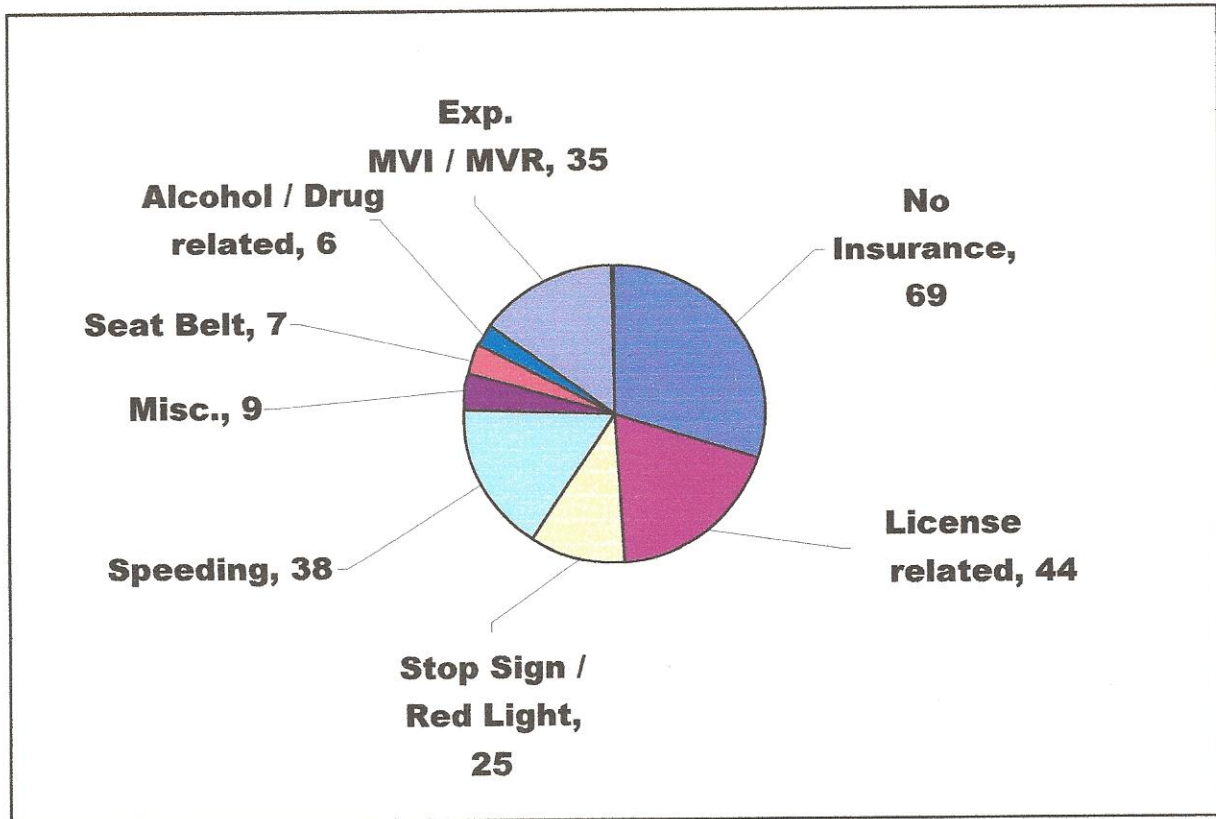
- **National Night Out** was Tuesday Oct. 7, we attended two events. The larger more city-wide event on Adams St. and the Homeowner Assoc. event in Lakeshore Estates. The Lakeshore event went very well; we were able to answer a lot of questions. The city-wide event was well attended and a lot of fun. I estimate about 200-300 people in attendance (come and go). We handed out some Child ID kits, collected email addresses for our weekly report, and displayed assorted equipment.
- Cpl. Gamez has provided me with an updated report on his **Junk Vehicle Abatement** assignment. As of today 15 vehicles have been moved or brought into compliance. Cpl. Gamez has 4 locations that will need more attention and he will be working on them in the next couple weeks. He will still be working to locate more vehicles that are in need of attention.
- **GroupCast Update:** We currently have 840 different numbers uploaded. We have are still collecting and receiving initial contact info. and will add that soon. (We have about 100 forms, which could be about 300 more numbers). Bottom line, our emergency contact system is operational.
- **Fire Marshal Training** : Matt and I have completed the on-line portion of the Fire / Arson Investigation class. We will be starting the Fire Inspection on-line portion this week. Everything is going as planned.
