

To give you an ideal the expo hall had three police helicopters on display. It was a massive event, to say the least. Over the course of three days I attended numerous education workshops, explored the expo hall and was present during two general sessions. Some of the speakers included U.S. Attorney General Jeff Sessions, FBI Director Christopher Wray and Cressida Dick who is the Commissioner of the Metropolitan Police in London. I also attended the Texas Police Chief's Assoc. breakfast. I stayed about 20 miles from downtown Philadelphia in Warminster PA, I rode the SEPTA train back and forth each day. That in itself was an adventure. If all goes well I hope to send Lt. Dear and Sgt. Hanson to this event next year which will be in Orlando FL.
