#### Message from the Chief of Police –

Lytle continues to thrive ... businesses look busy, and the roads are packed. Overall, our reports of crimes have been low. We did see a spike in vehicle burglaries and attempted vehicle burglaries over a period of several days. It appears that those were all related to the same crook. The problem with a low crime rate is that everyone becomes complacent and are more likely to leave valuables in their vehicles and leave homes and outbuildings unsecured. I know that I am guilty of that as well.

A lot more homes have security cameras that has been helpful to us by providing time frames and general descriptions of the suspect. If you have a home camera system, I suggest you spend some time getting familiar with it. Often there is camera footage, but nobody knows how to access it.

We now have new residents residing in Rosewood Estates (behind Lytle State Bank). In a few short years it is very likely that most of our population will live on the "other side" of IH-35. Before Saddle Ridge and Rosewood, I think we had less than 25 residents on that side of 35. The truck stop on IH-35 @ FM 3175 with the much anticipated IHOP is still under construction. If you drive by you can see it moving rather slowly, but it is still on track. We will be reaching for that blueberry syrup before you know it.

We are still currently fully staffed, and we should have two new Chevy Tahoe police vehicles joining our fleet very soon. Those are the same ones we ordered about one and one-half years ago.

We constantly evaluate our operations and have made numerous changes in our patrol procedures to enhance our services. I welcome your input and I am always ready to discuss our operations and plans as our city continues to grow.

# Field Sobriety Refresher Course On February 1, 2024, Capt. Matt Dear

SB 2273, which was adopted into law on September 21, 2023 (Section 37.0833 Texas Education Code) requires semi-annual countywide school safety meetings. This law applies only to counties with a population of less than 300,000, so for a "three counties" city like us that would be Atascosa and Medina Co. Sheriff David Soward hosted the first meeting on February 1, 2024, at the Sheriff's Office in Jourdanton. The law states who **shall** attend and the topics of discussion. Lytle P.D. was represented by Chief Richey Priest, Sgt. David Lopez, and Cpl. Danny Robison. Lytle I.S.D. was also well represented. It was a great opportunity for exchanging information and identifying resources.

On February 1, 2024, Capt. Matt Dear and Ofc. Roger Garcia attended an 8-hour standardized field sobriety refresher course used to help in D.W.I. arrests. The course was hosted by the Texas Municipal Police Assoc. and the Hondo Police Dept.
