CALL TO ORDER

Planning and Zoning Chairman Alex Sawicki called the meeting to order at 6:31 p.m. and read the notice of meeting aloud.

PUBLIC HEARING (IF ANY)

a. Conduct a Public Hearing Concerning a Preliminary & Final Plat of Alderete-Gutierrez Subdivision, Being 0.49
Acres, Establishing Lots 40 & 41, Being a Portion of Block 40 Lot 14, Lytle-San Antonio Irrigated Farms
Subdivision, as Shown on the Plat Recorded on Sheet 28-B, New Plat Cabinet, Atascosa County, Texas, And All of
Lots 25, 26, and 27 of the S G Cross Subdivision, as Shown on the Plat Recorded on Sheet 54-A1, New Plat
Cabinet, in the City of Lytle, Atascosa County, Texas.

Chairman Alex Zawicki opened the Public Hearing at 6:31 p.m.

City Administrator Zachary Meadows talked to the board members regarding the replat of four separate lots that they are looking to combine to make two lots. He explained that both lots would have to have their individual utilities and individual driveways. The only issue was the variances because they're zoning related. One of the variances is the lot width on lot 41, which the width at the right of way is required to be a minimum of 60 feet but they don't meet the requirement, they're at 43 feet off of Newton Drive. The second variance relates to keeping the existing structures and by doing so, they would be in violation of our side and rear setbacks.
