City Secretary Josie Campa reported that she had gotten a price of \$6,423.50 on a 15-phone Partner Plus system. She said the City could pay it out monthly on a 3-year, 4-year or 5-year plan, but said this would cost the City an additional \$1,800.00 to \$3,000.00 in interest and recommended this not be done. She told Council that the last phone system was ten phones and had cost \$5,000.00 ten years ago.

Ms. Campa told Council she had noticed the price quote was for all fifteen phones to be 18-buttons and that only half the phones would have 18-buttons; therefore, the cost of the new system would be even less. After discussion, Alderman Elias made the motion that Council approve the Partner Plus phone system, as presented by the City Secretary and that the budget be amended accordingly. Seconded by Alderman Trouart. Passed unanimously.

## CONSIDER AMENDMENTS TO 1998-1999 BUDGET FOR REMODELING CITY HALL

The Mayor and City Secretary explained some of the change orders needed in the remodeling project and the cost involved, and the need for some new furnishings to compliment the remodeling done in the City Hall.
