 - a. Public Hearing on proposed Ordinance No.22-13 amending Chapter 8 of the Lytle City Code to adopt current editions of the National Electric Code and the following International Code Council publications: the International Building Code, the International Plumbing Code, the International Residential Code, the International Mechanical Code, the International Existing Building Code, and the International Fuel Gas Code; creating new code sections to adopt the 2021 International Property Maintenance Code and the 2021 International Swimming Pool and Spa Code; and making certain local amendments to such codes.
 - b. Consider and Act upon Ordinance No. 22-13 Amending Chapter 8 – Buildings and Building Regulations, Article iii – Technical Codes and Standards to adopt current editions of the National Electrical Code and the following International Code Council publications: the International Building Code, the International Plumbing Code, the International Residential Code, the International Mechanical Code, the International Existing Building Code, and the International Fuel Gas Code; creating new code sections to adopt the 2021 International Property Maintenance Code and the 2021 International Swimming Pool and Spa Code; making certain local amendments to such codes; providing for penalties for the violation of this ordinance; providing for repeal of all ordinances in conflict; and providing cumulative, continuation, and severability clauses.
