

ORDINANCE NO. 22-04

AN ORDINANCE OF THE CITY OF LYTLE AMENDING ORDINANCE NO. _____ AND THE CITY OF LYTLE CODE OF ORDINANCES FINANCE DIRECTOR POWERS AND DUTIES; INCORPORATING RECITALS; PROVIDING A REPEALER; PROVIDING FOR SEVERABILITY; AND SETTING AN EFFECTIVE DATE

WHEREAS the City Council of Lytle adopted new Finance Director powers and duties at its June 13, 2022, Regular City Council Meeting;

WHEREAS the City Council wishes to amend Ordinance No. ____ Powers and Duties of the Finance Director; and

WHEREAS the City Council of Lytle finds it in the best interest of the city to implement the new powers and duties adopted for the Finance Director position; and

WHEREAS, effective immediately following the adoption of this ordinance by the City Council of the City of Lytle, the Finance Director duties and powers shall remain in effect unless otherwise changed by the City Council; **NOW THEREFORE**,

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF LYTLE THAT FINANCE DIRECTOR POSITION POWERS AND DUTIES ARE AMENDED AS FOLLOWS:

SECTION 1. At the Regular Meeting held on June 13, 2022, the City Council adopted new powers and duties for the position of Finance Director, in addition to those powers and duties provided in the Local Government Code Sections 22.071, 22.072, and 22.075 and as otherwise provided by State Law. The powers and duties are as follows in attached **Exhibit A** job description for the Finance Director incorporated herein for all purposes.

SECTION 2. INCORPORATING RECITALS

The City Council approves the recitals to this ordinance contained in the preamble hereto and incorporates them herein as findings of fact.

SECTION 3. REPEALER

All other ordinances, resolutions or parts thereof in conflict herewith are repealed to the extent of such conflict. All procedures adopted prior to the approval hereof are ratified and saved from repeal through the effective date.

SECTION 4. SEVERABILITY


If any section, subsection, sentence, clause or phrase of this ordinance is for any reason held to be unconstitutional or illegal, such decision shall not effect the validity of the remaining sections of this ordinance. The City Council hereby declares that it would have passed this ordinance, and each section, subsection, clause, or phrase thereof, irrespective of the fact that any one or more sections, subsections, sentences, clauses or phrases be declared void.

SECTION 5. EFFECTIVE DATE. This ordinance shall be effective immediately and shall remain in effect unless otherwise changed by the City Council.
