## ORDINANCE NO. 23-02

DECLARING THE UNOPPOSED CANDIDATES FOR THE OFFICES OF CITY COUNCILMEMBER PLACE #1, CITY COUNCILMEMBER PLACE #2, AND COUNCILMEMBER PLACE #3 TO BE ELECTED; INCORPORATING RECITALS; CANCELING THE ELECTION SCHEDULED FOR MAY 6, 2023 AND PROVIDING FOR THE NECESSARY POSTING OF THIS ORDINANCE.

WHEREAS, the City Council of the City of Lytle, Texas adopted Resolution No. 23-01 ordering the City General Election to be held on May 6, 2023, for the purpose of electing City Councilmember Place #1, City Councilmember Place #2, and City Councilmember Place #3; and

**WHEREAS**, pursuant to Sections 143.007 and 146.054, Texas Election Code, the deadline for filing applications for a place on the ballot and declaration of write-in candidacy for the City's general election have expired; and

**WHEREAS**, the City Secretary, in accordance with Section 2.052, Texas Election code, has certified to the City Council that the following candidates are unopposed for election to the office in the general election to be held on May 6, 2023:

COUNCILMEMBER PLACE 2
COUNCIL MEMBER PLACE 3

**WHEREAS,** Election Code Section 2.053(a) provides authority for the City Council to declare the unopposed candidates as elected to office and cancel the election, and provides that the order or ordinance so declaring must be posted on election day.

## NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF LYTLE, TEXAS, THAT:

- **Section 1.** The above-listed recitals of this Ordinance are hereby found to be true and correct and incorporated herein for all purposes.
- **Section 2.** Miguel Aguirre is declared elected Councilmember Place 1; Richard Hughes is declared elected Councilmember Place 2; and David Emery is declared elected Councilmember Place 3.
  - **Section 3.** The city general election scheduled for May 6, 2023 is hereby canceled.
  - **Section 4.** The City Secretary is hereby directed to post a copy of this Ordinance

at polling place Lytle City Hall located at 14916 Main Street, Lytle Texas 78052, on May 6, 2023 and throughout the early voting period.
